NOTICE OF PUBLIC MEETING AND PUBLIC HEARING ON

BUDGET FOR FISCAL YEAR 2021 AND

CERTIFICATION TO HOLD VIDEO CONFERENCE MEETING

In accordance with the Executive Proclamations JBE 2020-30 issued by Governor John Bel Edwards on March 16, 2020 and the Concurrence by the Attorney General on March 19, 2020 and all Proclamations extending the Orders issued therein, this Notice shall serve as Certification of the Florida Parishes Juvenile Justice Commission's inability to otherwise operate in accordance with the Louisiana Open Meetings Law due to a lack of quorum as a result of the COVID-19 Public Health Emergency.

Pursuant to Section 4 of JBE 2020-30, *et seq.*, the Florida Parishes Juvenile Justice Commission will provide for attendance at its essential governmental meeting on June 10, 2020 via ZOOM Conference in order to obtain a quorum of its members.

Notwithstanding the foregoing, the Florida Parishes Juvenile Detention Center shall be open to the general public for attendance at that facility for any member of the public wishing to participate in the Public Meeting and particularly any Public Hearing relating or otherwise arising from the Florida Parishes Juvenile Justice Commission's Annual Budget for the Fiscal Year 2021.

Members of the public who wish to attend the Public Meeting and Public Hearing for any purpose, including, but not limited to a Public Hearing on Budget are invited to attend and are granted entry. Notwithstanding entry, all persons shall maintain a social distance of no less than six (6) feet from others present and shall at all times utilize an approved mask over the face, nostril and mouth.

The Florida Parishes Juvenile Justice Commission will utilize the online platform, ZOOM, to livestream the meeting. The livestream will be available for viewing by any member of the public wishing to participate by ZOOM.
